Dear Interested Crafter:

We are so pleased that you are interested in participating in our Annual Gifts and Goodies Boutique. We have enclosed several pages of information for you. Applications received by June 1, 2009 will undergo the first round of judging.

Please read the front and back of all the following pages before completing the application. We have many crafters interested in being in our show and we ask that you follow all of the enclosed rules and regulations closely. Pay close attention to the due date and what you are required to submit. **You are required to submit a photocopy of your Seller's Permit.** Make sure your application is signed, driver's license # provided, and dated on the back of your application. Applications that do not follow the process completely will be returned without being judged.

❖The location of the Boutique will be at the Norman P. Murray Community Center. There is plenty of crafter parking on-site!

JUDGING PROCEDURE

*All submitted photos (5 photos of your merchandise and 1 photo of you creating your items) will be judged by a panel of three to five independent judges.

*All merchandise will be judged on the following criteria:

- A. Quality
- B. Presentation
- C. Creativity
- D. Adherence to Handcrafted Policy
- E. Uniqueness
- F. Overall Appeal to Judges
- G. Balance of Merchandise for Boutique

*Judging will take place from June 1- 8, 2009

* All first round acceptance or denial letters will be sent by June 30, 2009

*All photos of accepted entries will be held until the Boutique to ensure that only qualified merchandise appears in the booth. Should a first round choice decline to participate, their photos will be returned at the time MVAC receives their cancellation request.

TERMS & CONDITIONS OF USE:

The Mission Viejo Activities Committee reserves the right to remove, without refund, any person and/or merchandise not complying with the following regulations:

A. All items must be handcrafted, no wholesalers or sales reps. **Absolutely no wholesale, manufactured or imported merchandise allowed.**

B. All items must be appropriate to the spirit of a family oriented sale.

C. MVAC is not responsible for damage to merchandise or cancellation of the Boutique in whole or part due to fire, windstorm, lightning, rain or any other inclement weather. MVAC spends substantial sums in preparation and advertisement of this event and refunds for spaces cannot be made in the event the Boutique is cancelled in whole or in part by such Acts of God.

D. MVAC reserves the right to change the show layout or space locations if it becomes necessary.

E. MVAC does not provide tables, chairs or any other fixtures or supplies.

F. Set up for the Boutique will be between 4:00PM and 9 PM on the Friday before the event.

H. **All vendors are to remain at the sale from 8 AM to 5 PM.** This is important to both the customers and the aesthetics of the event. Vendors not complying with this will be removed from the mailing list and will not be asked to participate again.

I. All applications must be postmarked by June 1, 2009 to be considered for booth space in the first round of jury selection, entries postmarked after the deadline will be considered only if spaces remain available.

J. Only one booth assigned per application. If more than 1 vendor will share the booth, each vendor must submit a complete application and photos to be judged.

K. If selected by the jury and you were a vendor in the 2008 Boutique, you may request your same space and room as last year. However, if you want to change, you can make a request and we will fill request if possible according to the date application is received. Spaces are assigned by the committee with as much effort as possible to give you your 1st choice and to best distribute merchandise throughout the Boutique.

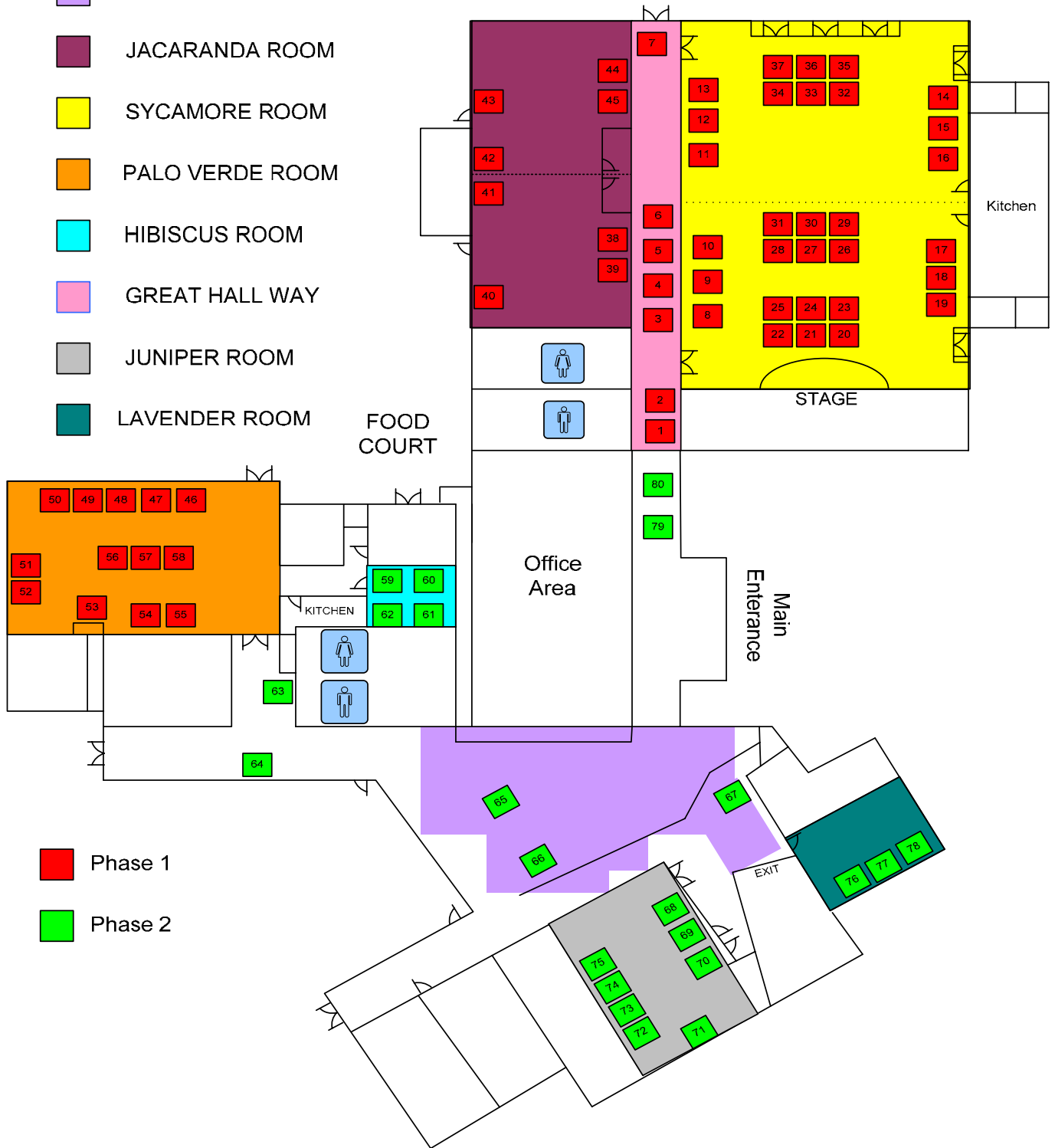
